2. Governance



I. General

- ¹ The General Terms and Conditions (GTC) apply to all trainings, advanced trainings and advanced trainings conducted by SWISS TCM UNI.
- ² The registration, by whatever means, is completed and legally binding with the signing of the registration form.
- ³ By signing the registration form, the student or participant enters into an education, training and continuing education contract with SWISS TCM UNI and accepts the General Terms and Conditions of SWISS TCM UNI, which are an integral part of the contract.
- ⁴ In the case of training, further training and continuing education provided by cooperation partners, the general terms and conditions of the cooperation partner may supplement or replace these GTC. The details are regulated in the registration confirmation.

II. Registration and confirmation of registration

- ¹ The exact registration dates for trainings, advanced trainings and advanced trainings can be found on the website of SWISS TCM UNI and are to be observed by the student.
- ² Registration can be made in person or in writing by e-mail, letter post, fax or via the SWISS TCM UNI website.
- ³ If the registration is made via the website, the signature is replaced by a corresponding click during the registration process.
- ⁴ Each registration requires a signature of the student.
- ⁵ In the case of training and further education courses, the study committee shall make a final decision on the basis of the documents submitted as to whether the admission requirements have been met and as to admission.
- ⁶ The education and training contract between the student and SWISS TCM UNI comes into effect with the written confirmation by SWISS TCM UNI. It should be noted that the registration for a training and further education course is binding in any case.
- ⁷ In the case of further education and training courses without participation requirements, registration is binding in accordance with paragraphs 2 and 4.

III. Financial provisions

§3.1 Terms of payment

- ¹ The training fee is generally due and payable 30 days before the start of the training event. All prices are quoted in CHF.
- ² The exact starting dates of the educational event can be found on the SWISS TCM UNI website.
- ³ For training and further education courses lasting longer than 3 semesters, a discount of 2% will be granted if the total amount is paid in advance 10 days before the start date.
- ⁴ The training fees include teaching materials according to the announcement, documentation of the lecturers as well as on-site supervision and all regular examinations. Not included are costs for meals,



travel and accommodation, retaking or repeating learning achievements (e.g. examinations, written work), repeating lessons, modules or courses of study, supplementary literature, personal acquisition of teaching materials as well as the return of unneeded teaching materials, etc.

⁵ SWISS TCM UNI does not grant any deductions from the tuition fees due to absence, military service, illness, maternity, accident, vacations or professional stress.

§3.2 Pricing

- ¹ The education fee is guaranteed for the standard period of study and remains unchanged.
- ² After a cancellation and re-registration by the student or participant, the currently valid education fees apply for the new registration.
- ³ SWISS TCM UNI reserves the right to adjust the prices according to any program changes.
- ⁴ All price changes will be communicated to the students or participants at least 3 months in advance.

§3.3 Payment in instalments

- ¹ It is possible to pay the education fee by instalments. Instalment payments are possible from a minimum amount of CHF 3,000.
- ² Instalment payments are only accepted by SWISS TCM UNI under the following conditions:
- ^{2.1}The instalment payment has already been discussed with and approved by the administration of SWISS TCM UNI prior to registration for a training or continuing education course.
- ^{2.2} The request for payment by instalments must be sent in writing (e-mail) to the administration of SWISS TCM UNI within 14 days after receipt of the invoice.
- ^{2.3} The first payment must be received by SWISS TCM UNI before the start of the training or continuing education.
- ³ Modalities of payment by instalments:
- ^{3.1} In case of a quarterly instalment payment, a surcharge of 3% on the total education fee will be applied.
- ^{3.2} In case of a monthly instalment payment, a surcharge of 5% on the total education fee will be applied.

§3.4 Discount

- ¹ Discount for students or participants for repeating the entire course (CAS, semester, module without new teaching material): 20% on the educational fees.
- ² discounts for employees of companies or members of organizations: according to contracts between SWISS TCM UNI and the company or organization.



§3.5 Default of payment and reminder

- ¹ SWISS TCM UNI reserves the right to suspend or exclude students or participants who do not meet their payment obligations in due time. In any case, the full amount of the course fee must be paid before completion of the course.
- ² In case of late payment, a default interest of 5% per year and a reminder fee of CHF 65.- will be charged from the due date of the invoice.

IV. Implementation and organization

§4.1 Postponements and cancellations by SWISS TCM UNI

- ¹ SWISS TCM UNI reserves the right to cancel or reschedule its education, training and continuing education programs if the number of students or participants is too low.
- ² This also applies if a course has to be cancelled or interrupted for important reasons or as a result of force majeure.
- ³ Important reasons may include, for example, accident or illness of lecturers who are significantly involved in the course and for whom no adequate replacement can be found in the necessary time.
- ⁴ In all of the above cases, the fees already paid by the student or participant for said education, training and continuing education programs will be refunded in full.
- ⁵ The reasons for the cancellation or termination must be disclosed and communicated to the student or participant.
- ⁶ All further liability claims are excluded.

§4.2 Changes in content and personnel by SWISS TCM UNI

SWISS TCM UNI reserves the right to change the content of educational programs and courses, or to have them conducted by other lecturers or external specialists, or to postpone them to another time. This applies to individual courses as well as to the entire program.

V. Cancellation and rebooking

§5.1 Deregistration before the start of the education and training program

- ¹ The student or participant must give written notice of withdrawal from the program.
- ² If the cancellation is received by SWISS TCM UNI after receipt of the confirmation of registration, but still 45 days before the start of the education and training program, no costs will be incurred by the student or participant.
- ³ If the cancellation is received by SWISS TCM UNI after receipt of the confirmation of registration, but 30 days before the start of the training, an administration fee of CHF 200.00 will be charged.
- ⁴ If the cancellation is received by SWISS TCM UNI after receipt of the confirmation of registration, but up to 15 days before the start of the education and training, the entire fee for one semester will be charged.



⁵ Education fees will not be refunded. If students or participants are prevented from attending due to accident or illness, they can make up the course at a later date in consultation with the university management.

§5.2 Rebooking before the start of the education and training program

- ¹ Prior to the start of the entire training and continuing education program, participants may rebook for other training and continuing education programs or postpone the start of the training and continuing education program.
- ² A rebooking or postponement after the confirmation of registration up to 30 days before the start of the training and further education shall be free of charge. Thereafter, an administration fee of CHF 250 is payable.
- ³ In the event of a rebooking to another training or further education course, the fee for the new training or further education course will be applied and any difference will be credited or subsequently invoiced.

§5.3 Rebooking during training and continuing education

- ¹ Rebooking or postponement of modules or semesters during education and training is possible before the start of the module or semester.
- ² The postponement leads to an interruption of the education and training and requires a new registration, for which the current education and training fees apply.
- ³ If only the change of the sequence or the exchange of modules or semesters according to the program of the education and training is planned, no additional fees arise

§5.4 Withdrawal during education and training

- ¹ Early withdrawal from continuing education (CAS, DAS, MAS) is possible at the end of each semester or from education (BSc, MSc, PhD) at the end of the module.
- ² Cancellation must be made by registered letter to the Administration no later than 30 days before the start of the next semester or module.
- ³ If this deadline is not met or if the student withdraws during the semester, the full semester fee is due for payment.
- ⁴ In the event of withdrawal from a Master's degree program (MAS), the difference between the tuition fee for the individual courses (CAS, DAS) and the paid portion of the tuition fee for the Master's degree program must be paid in arrears.

§5.5 Interruption of education and training

¹ Training or continuing education may be interrupted and continued and completed at a later date.

- ² The interruption must be applied for in writing.
- ³ The interruption shall not give rise to any additional fees.

⁴ If the maximum duration of the education or training is exceeded due to the interruption, this will be treated as a termination or re-registration.

VI. De-registration by SWISS TCM UNI

- ¹ SWISS TCM UNI reserves the right to expel students or participants from the training and further education at SWISS TCM UNI due to unlawful, objectionable and disciplinary misconduct.
- ² With the de-registration of the student or participant, the education and training contract between SWISS TCM UNI and the student becomes invalid.
- ³ The student or participant shall be liable for the entire training fee in accordance with the training and further education contract as well as any compensation costs.
- ⁴ SWISS TCM UNI will issue a confirmation to the student or participant for the courses already completed by the student or participant.

VII. Insurance and liability

- ¹ SWISS TCM UNI and its employees do not assume any liability for education, further education, internships and study trips.
- ² SWISS TCM UNI assumes no liability for any damage incurred, be it personal injury or damage to property.
- ³ Neither SWISS TCM UNI nor its employees are liable for personal belongings of students or participants.
- ⁴ The student or participant is responsible for sufficient insurance coverage and its payment.
- ⁵ Entering and using the premises of SWISS TCM UNI and all objects in the possession of SWISS TCM UNI is at the student's own risk.

- ¹ The logo of SWISS TCM UNI including all teaching materials of SWISS TCM UNI and its partners are protected by copyright.
- ² Reproduction in printed or electronic form is expressly prohibited without the permission of the author or SWISS TCM UNI or its partners.
